

2. 申請流程 Application Procedures

Step 1	請先確認是否符合 外國學生 申請資格,請參考【 <u>I-4.申請身分資格</u> 】。 Please refer to the " <u>I-4. Eligibility</u> " section to check your application eligibility.
Step 2	本校僅開放外國學生申請 <u>秋季班</u> 入學,請參考【 <u>II-4.系所資訊</u> 】確認欲申請之 <mark>系所及學制</mark> 。 The application is only for <u>Fall Semester</u> . Please refer to the " <u>II-4. Program Information</u> " section to confirm the departments and academic degrees you wish to pursue.
Step 3	請於 2025 年 11 月 18 日至 2026 年 1 月 6 日至本校【 <u>外國學生網路報名系</u> <u>統</u> 】以有效電子郵件信箱註冊一組帳號密碼並上傳申請資料。 Please register an account at <u>Online Application System for International Students</u> and complete the application during November 18 th , 2025~January 6 th , 2026.
Step 4	未於 2026 年 1 月 6 日前完成上傳並點按【確認送出】即視同放棄申請;若 有問題將以作為報名註冊帳號之電子郵件信箱聯繫。 If you receive our e-mail (oia20@gm.nutc.edu.tw), please reply us to confirm your online application before January 6 th , 2026.

3. 修業期限 Program Duration

依據「<u>國立臺中科技大學學則</u>」之相關規定辦理。四年制學士班修業期限四年,所修學分總數至少須修滿 128 學分;畢業年級相當於國內高級中等學校二年級之國外或香港、澳門同級同類學校畢業生,以同等學力資格入學大學學士

班者(簡稱中五學制學生,不含已離校二年以上者),應於註冊入學後增加其應修習之畢業學分數至少12學分,增加之學分數及修習科目別由各學系訂定之; 二年制學士班修業期限為二年,所修學分總數至少須修滿72學分。碩士生修業期限以一至四年為限,不包括畢業論文至少應修24學分。各學制在修業期限內, 未能修足規定學分或有特殊情況者,得延長修業期限。

According to "<u>Academic Policy of National Taichung University of Science and Technology</u>", officially enrolled students shall complete their undergraduate programs within 2 to 6 years, master programs within 1 to 4 years. For each academic program, if the required credits are not completed within the study period or in cases of special circumstances, an extension of the study period may be granted.

4. 申請身分資格 Eligibility

外國學生之身分認定係依據教育部「<u>外國學生來臺就學辦法</u>」及「<u>國立臺中</u> 科技大學外國學生申請入學要點」辦理。

According to the "<u>Regulations Regarding International Students Undertaking Studies in Taiwan</u>" issued by the Ministry of Education and "<u>National Taichung University of Science and Technology International Student Admissions Regulations</u> (Chinese Only)" international student is defined as follows:

- A. 具外國國籍且未曾具有中華民國國籍【註1】,符合下列規定者,得申請入學: A person of foreign nationality who has never held Republic of China ("R.O.C.") nationality N 1, and meet the following requirements is permitted to apply for admission to our university:
 - a. 未曾以僑生身分在臺就學。

A person has never previously undertaken studies in Taiwan as an overseas compatriot student.

b. 未於申請入學當學年度依僑生回國就學及輔導辦法經海外聯合招生委員會分發。

A person has never accepted a placement by the University Entrance Committee for Overseas Compatriot Students in the current academic year.

B. 具外國國籍且符合下列規定,且最近連續居留【註2】海外(不含香港、澳門及中國大陸地區)六年【註3】以上者,得申請入學。

A person of foreign nationality who meets the following requirements and who in the immediate past has continuously resided N 2 overseas (excluding Hong Kong, Macau, and Mainland China) for at least six years N 3 at the time of application is permitted to apply for admission.

- a. 申請時兼具中華民國國籍,應自始未曾在臺設有戶籍。
 - A person at the time of application also holds dual ROC nationality shall have never had household registration in Taiwan.
- b. 申請前曾兼具中華民國國籍,於申請時已不具中華民國籍者,應自內政部許可喪失中華民國國籍之日起至申請時已滿八年【註3】。

A person who before the time of application also held dual R.O.C. nationality but no longer does at the time of application shall have renounced their ROC nationality with the approval of the Ministry of the Interior on a date for at least eight full years $^{\rm N\,3}$ before making the application.

c. 前二款均應符合前項第一款及第二款規定。

The persons referred to in the preceding two subparagraphs must meet the subparagraphs a and b in paragraphs A.

C. 依教育合作協議,由外國政府、機構或學校遊薦來臺就學之外國國民,其自始 未曾在臺設有戶籍者,經教育部核准,得不受前二項規定之限制。

A foreign national who was selected by a foreign government, organization, or school to study in Taiwan in accordance with the Education Cooperation Framework Agreement, and who has never had household registration in Taiwan may be given exemption from the restrictions set out in the above provisions if the Ministry of Education gives approval.

D. 具外國國籍,兼具香港、澳門永久居留資格,且未曾在臺設有戶籍,申請時於香港、澳門或海外連續居留【註2】滿六年【註3】以上者,得申請入學。

An applicant of foreign nationality, who is eligible for permanent residence in Hong Kong or Macao, who has never had household registration in Taiwan, and who at the time of application has continuously resided N2 in Hong Kong, Macao, or elsewhere overseas for at least six years N3 may apply for admission.

E. 曾為大陸地區人民具外國國籍且<mark>未曾在臺設有戶籍</mark>,申請時已連續居留【註2】 海外六年【註3】以上者,得申請入學。

A foreign national who was formerly from Mainland China, has never had household registration in Taiwan, and has continuously resided N 2 overseas (excluding Hong Kong, Macau, and Mainland China) for at least six years N 3 at the time of application may apply for admission.

F. 外國學生依以上規定申請來臺就學,以一次為限;其繼續在臺就學者,入學方式應與我國內一般學生相同。但下列情形,不在此限:

An international student applying to study at an educational institution in Taiwan in accordance with the above provisions is limited to only applying once; and if the student wants to continue studying in Taiwan, the application shall be handled in the same manner as the admission procedures for domestic students, however, not limited by the following subparagraphs:

a. 於完成申請就學學校學程後,申請碩士班以上學程,逕依本校規定辦理。

After completing the course of study at the educational institution to which they applied, if the student is applying for admission to a program for a master's degree or a higher degree, which may be handled by each university in accordance with its regulations.

b. 外國學生申請來臺就讀學士班以下學程,在國內停留未滿一年,因故退學或 喪失學籍,得重新申請來臺就學,並以一次為限。

An international student who applied and studied in any undergraduate programs in Taiwan for less than one year and then dropped out or lost his/her student status for some reason may apply to study in Taiwan one more time.

- c. 外國學生已於國內公私立大學就學者,得申請轉入本校學士班二年級或性質 相近三年級就讀。
 - An international student who studies in other universities may apply to enroll in the second or third year as a transfer student.
- d. 在我國就讀外國僑民學校或我國高級中等學校附設之雙語部(班)或私立高級中等以下學校外國課程部(班)畢業者。

An international student who has graduated from a private elementary or secondary school for international residents in Taiwan, or from a bilingual division (program) affiliated to a domestic senior secondary school, or from a program teaching a foreign curriculum that is offered by a division of a domestic private elementary school, junior high school or senior secondary school, may apply for admission.

G. 外國學生曾經入學學校以操行或學業成績不及格、違反法令或校規情節嚴重 致遭退學或喪失學籍者,不得再申請入(轉)學。

If an international student who has been dismissed by the educational institution that admitted the student as a result of conduct was unsatisfactory, or if the student seriously violated its regulations or was sentenced in criminal case proceedings, and therefore in accordance with the provisions of the regulations governing student awards and penalties had to discontinue their studies or forfeited their status as a

registered student, the student is not permitted to re-apply for our university.

- 【註1】依『國籍法第二條』規定,有下列各款情形之一者,屬中華民國國籍:
- [N 1] According to Article 2 of the Nationality Act, a person shall have the nationality of the R.O.C. under any of the conditions provided by the following subparagraphs:
 - 出生時父或母為中華民國國民。
 His/Her father or mother was s national of the Republic of China when he/she was born.
 - 出生於父或母死亡後,其父或母死亡時為中華民國國民。 He/She was born after the death of his/her father or mother, and his/her father or mother was a national of the R.O.C. at the time of death.
 - 出生於中華民國領域內,父母均無可考,或均無國籍者。 He/She was born in the territory of the R.O.C., and his/her parents can't be ascertained or both were stateless person.
 - 歸化者。 He/She had undergone the nationalization process.
- 【註2】連續居留係指外國學生每曆年在國內停留期間未逾120日(計算至2026年8月1日)。連續居留海外採計期間之起迄年度非屬完整曆年者,以各該年度之採計期間內在國內停留期間未逾120日予以認定。但符合下列情形之一且具相關證明文件者,其在國內停留期間,不併入海外居留期間計算:
- [N 2] The term "reside overseas continuously" means that an international student has stayed in Taiwan for no more than a total of 120 days in each calendar year (calculating till August 1st, 2026). When calculating the number of consecutive years spent overseas, if the initial or final year of the period is not a complete calendar year, any time spent in Taiwan in the initial or final year must not exceed 120 days. However, time that a person has spent in Taiwan is not subject to this restriction and it is not counted when calculating how long he/she was in Taiwan in a particular year if the person has documentary proof that he/she:
 - 就讀於僑務主管機關舉辦之海外青年技術訓練班或是教育部認定之技術訓練專班。 attended an overseas youth training course organized by the Overseas Compatriot Affairs Council or a technical professional training program accredited by the

Ministry of Education;

- 就讀教育部核准得招收外國學生之各大專校院華語文中心,合計未滿二年。 spent a total period of less than two years undertaking Chinese language classes at a Chinese language center at a university or tertiary college which has Ministry of Education approval to recruit students overseas;
- 交換學生,其交換期間合計未滿二年。 spent a total period of less than two years in Taiwan as an exchange student; or
- 經中央目的事業主管機關許可來臺實習,實習期間合計未滿二年。 spent a total period of less than two years undertaking an internship that they came to Taiwan to undertake with the approval of the designated central competent authority.
- 【註3】以上所稱六年、八年,以擬入學當學期起始日期(2026年8月1日)為終日計算之。
- [N 3] The periods of six years and eight years shall be calculated using the starting date of the semester (August 1st, 2026) as the end date of the period.

5. 入學學歷資格 Qualification for Admission

A. 符合教育部採認之高中、大學或獨立學院畢(肄)業者,請參考教育部「<u>外國</u>大學校院參考名冊專區」。

Graduates from a high school, university, or independent academy, which is recognized by the Ministry of Education, are eligible to apply for admission. Please refer to the "Database for the Reference List of Foreign Universities".

- B. 符合教育部「入學大學同等學力認定標準」之同等學力資格者。 Individuals with equivalent degrees stipulated in "Standards for Recognition of Equivalent Education Levels for University Admission" by the Ministry of Education are eligible to apply for admission.
- C. 持境外學歷申請者,須符合各該相關學歷採認法規之規定(大學辦理國外學歷 採認辦法、大陸地區學歷採認辦法、香港澳門學歷檢覈及採認辦法)。 The assessment and recognition of foreign academic records shall be undertaken in accordance with the provisions of the related regulations, such as the "Regulations Governing the Assessment and Recognition of Foreign Academic Records by Institutions of Higher Education", the "Regulations Regarding the Assessment and Recognition of Academic Credentials for Mainland Area", and the "Regulations Governing the Examination and Recognition of Educational Records from Hong Kong and Macao."
 - a. 大陸地區學歷:請依「<u>大陸地區學歷採認辦法</u>」規定辨理。
 Academic credentials from the Mainland Area: shall be handled in accordance with the provisions of the "<u>Regulations Regarding the Assessment and Recognition of Academic Credentials for Mainland Area</u>".
 - b. 香港或澳門學歷:請依「香港澳門學歷檢覈及採認辦法」規定辦理。 Academic credentials from Hong Kong or Macao: shall be handled in accordance with the provisions of the "<u>Regulations Governing the Examination and</u> <u>Recognition of Educational Records from Hong Kong and Macao</u>".
- c. 其他地區學歷: Academic credentials from other areas 海外臺灣學校及大陸地區臺商學校之學歷同我國同級學校學歷。 Academic credentials issued by an Overseas Taiwan School or a school for Taiwan business people in the Mainland Area shall be regarded as equivalent to academic credentials issued by an educational institution of the same level in Taiwan.
- d. 其他國外地區學歷,應依「大學辦理國外學歷採認辦法」規定辦理。但設校或分校於大陸地區之外國學校學歷,應經大陸地區公證處公證,並經行政院設立或指定之機構或委託之民間團體驗證。
 Academic credentials from overseas other than those mentioned above shall be handled in accordance with the provisions of the "Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education". However, academic credentials issued by a campus or branch that a foreign educational institution has established in the Mainland Area by a foreign educational institution shall be notarized by a notary public there and authenticated by an agency established or designated by the Executive Yuan, or by a private organization commissioned by the Executive Yuan.

 - 特殊情況繳交資料說明 Submitting Printed Materials 具特殊原因可另以電子郵件寄至 oia20@gm.nutc.edu.tw, 信件標題註明【2026 Fall 外國學生申請入學報名】;無法以電子檔繳交而需以郵寄方式繳交紙本資料者,請填妥簡章「附件五:郵寄信封封面」,並黏貼於自備之信封,所有資料須依「個人資料及備審資料」之項目裝入信封內。倘若檢附之書面資料不齊導致權益受損時,概由申請人自行負責。另外,所有申請文件一律概不退還,請自行保留備份。

本校課程皆以中文授課為主(智慧營運與經營管理外國學生碩士專班、應用日語系日本市場暨商務策略碩士班、資訊工程系重點產業領域碩士班以及應用英語系部分課程除外),請依 II-4.系所資訊 (P.8-12) 中各系所之要求,檢附相當於華語文能力測驗基礎級 (TOCFL Level 2) 以上證明為佳。

All programs are conducted in Chinese Mandarin, except for International Master of Business Administration in Intelligent Operations Program, Graduate Program of Japanese Marketing and Business Strategies, Key Industrial Master Program of Computer Science and Information Engineering and English related courses of Department of Applied English, thus applicants shall provide TOCFL Level 2 (CEFR A2) or higher certificate of Chinese Proficiency according to II-4. Program Information (p.8-12) as a favorable basis for the admission qualification review.

An international student who submits any certificate or document as part of their application for admission to an educational institution that is found to be forge, fabricated, or that has been alert in some way shall have their enrollment eligibility revoked. If the student has already registered and begun classes, their registration as a current student shall be cancelled and they will not be awarded any certification whatsoever regarding their related academic undertakings. If any such circumstances are first discovered after a student has already graduate, our university has to revoke the former student's eligibility to graduate and require any degree already awarded to be returned and rescind it.

4. 獎助金及相關支援 Scholarships and Support System

We provide scholarship for international students.

A. 本校外國新生第一年可獲得學雜費半額減免之獎助金,第二年起若前一年之學士班學業平均成績達75分/碩士班學業平均成績達80分以上,且操性平均達80分以上,並通過外國學生獎助金審查會議,則可以獲得半額,甚至全額之學雜費減免。

International students shall receive half tuition fee deduction for the first year

studying in the program. From the second year of the program, they shall be qualified for half or even full tuition deduction as long as their average academic score of the previous year is above 75 for undergraduate programs / 80 for master's programs and the behavioral conduct score is above 80 and also pass the review process by the international scholarship committee.
